Highlights of the January 20, 2017, Trustees' Meeting

1. CEO's Report

• The customary overview of claims statistics was presented.

2. Retirement Incentive for Disability Recipients (also known as RITE)

- In 2017, the ASEBP Trustees will be offering a retirement incentive for disability recipients to covered members on Extended Disability Benefits who meet the criteria. The RITE program gives individuals the opportunity to accept a cash offer in exchange for moving off disability, giving ASEBP the chance to reduce its future financial obligations (claims payments and reserves).
- To be eligible for RITE, individuals must be:
 - 55 years of age or older,
 - on disability at least 2.5 years,
 - not previously offered RITE,
 - not involved in litigation, and
 - offered over \$1,000.
- RITE includes a tax-free lump sum as well as benefits coverage to age 65. The lump sum will also factor in a cost-of-living allowance.
- All eligible candidates will receive an offer from ASEBP by May 1 for a June 30 retirement date. ASEBP will be holding information sessions for RITE candidates and will be encouraging them to seek financial and legal advice to support their decision making.
